**Re: Highway Surfacing Newsletter Update
Harrier Way, Hunts Grove**

Following the completion of Phase 1 of the surfacing on Harrier Way, we appreciate your patience with the works and trust the closure was not too disruptive. As previously noted we wanted to provide you with an update on the next planned phase of surfacing to the road.

Phase 2:

Phase 2 consists of Harrier Way from just north of the crossroads with Lime Tree Avenue and Red Kite Rise to the junction with Hunts Grove Drive (but not including Hunts Grove Drive).

The works will involve adjustments to the kerbs near Hunts Grove Drive, planing of areas of the existing carriageway; excavation of damaged surfacing and culminating in the laying of new tarmac to form the finished surface.

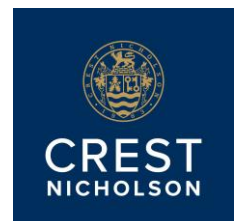
The works will take place over the next few weeks replacing damaged kerbs along the road working towards the junction with Hunts Grove Drive. In order for this work to be undertaken safely it will be necessary for temporary traffic signals to be used at times during this period (anticipated w/c 4th November).

When?

The works in advance of surfacing will take place between 28th October and 8th November 2024, which as noted above will require some localised traffic management using temporary signals.

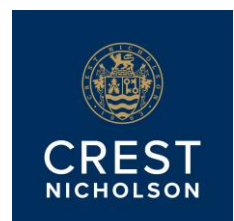
The second phase of surfacing is then proposed for week commencing 11th November for a period of 5-days.

As before, from the **11th November** there will need to be a complete closure of Harrier Way between points D, E & F shown on the plan above – during much of this time there will need to be restricted access to driveways for those residents who front Harrier Way due to the type of works needing to

be undertaken, but the site team will seek to accommodate residents when at all possible and will contact these residents directly. The refuse team at Stroud District Council will also be made aware of these works and as before there should be no disruption to bin collections, but further updates will be provided should bins need to be put out at different times or locations.

The closure will also involve the footpaths and it is proposed the diversion for the footpath will be provided from the play area path accessed from Marconi Drive, onto Tawny Close and Red Kite Rise (indicated by the green arrows).

During the closure the diversion route will be signed and will be along Harrier Way past the school and onto Hunts Grove Drive and Marconi Drive.

Unfortunately it will not be possible to allow buses to access Hunts Grove safely and so the bus service will be temporarily stopped with the bus only coming as far as the roundabout at the end of Waterwells/Marconi Drive. Details of the nearest bus stops will be posted on the stops in advance.

Phase 3

The final section of surfacing at the junction of Lime Tree Avenue and Red Kite Rise will be communication in the coming weeks.

The above dates are subject to change if unforeseen issues arise, but the closures will also be limited or shortened if at all possible, with further updates to be provided as the work progresses.

We appreciate your ongoing cooperation with these works and always seek to minimise disruption as much as possible.
